PRiSM Pays Tribute to Timothy R. McCormick

On October 2nd, the fall PRiSM event was held at the Rochester Riverside Convention Center in honor of Timothy R. McCormick, Unity Health System's long-serving president and chief executive officer, who will retire at the close of 2009. The evening was full of Tim's "favorite things"—represented by a Seton Hall themed cocktail party followed by dinner and dancing. Tim and his wife, Joan, were joined by their family and 350 friends.

NYS Senator Joseph Robach served as master of ceremonies. Long-time Unity Board Member and friend, Patricia H. Wehle, and Dr. Nagendra Nadaraja, Unity Board member and chief of Surgical Services at Unity Hospital, both paid heartfelt tributes to Tim. Kelly McCormick-Sullivan and T.J. McCormick shared many humorous stories about their father. There were also many laughs and a few tears during the slideshow of Tim's 36-year career with Unity.

Bishop Matthew Clark offered the invocation. Monroe County Executive Maggie Brooks and Rochester Mayor Robert Duffy declared Friday, October 2, 2009 to be "Timothy R. McCormick Day." Rochester Deputy Mayor Patty Malgieri and Monroe County Legislator Jeffrey McCann were on hand to personally present the proclamations.

Foundation President Timothy J. Balconi recognized the August Family for the generous challenge grant they made for the Timothy R. McCormick Transitional Care Center. In particular, he thanked Burt August for his lifetime of philanthropic giving and very generous support to Unity over the years. The \$100,000 raised at the dinner pushed the total gifts received to name the new Transitional Care Center after Tim McCormick past the \$1 million goal.

Thank you to everyone who made the evening a memorable one for Tim McCormick and his family.

At this writing, it is with great personal sadness that I extend my deepest sympathies to the family of Mr. Charles J. August, a long-time Unity Health System leader and supporter. Charles' contributions to the growth and success of the Health System have been numerous over the decades. His warmth and leadership will be deeply missed by all of us at the Unity Health Foundation.

Thanks to the generosity of the August Family and the steadfast support of our donors, the Foundation has raised over \$1 million for the new Timothy R. McCormick Transitional Care Center. The new facility, now under construction on the Unity Park Ridge Campus, is scheduled to open in April 2010. Also scheduled to open in the spring of 2010 are the Wegman Family Cottages, also part of the Park Ridge Living Center, and I am happy to report that we are nearing our goal of \$4.1 million for the entire project, with over \$4 million raised to date.

The Foundation is also pleased to announce that it recently received generous gifts from Mr. Robert Bell, and Mr. and Mrs. Erich Postler in support of the new Endovascular Suite, an up-coming project planned for Unity Hospital. The Suite will provide cutting-edge operating room technology for less-invasive endovascular procedures.

Additionally, the Foundation is happy to report a generous \$217,000 gift from the Dr. William Liberston and Ruth Eileen DeGraw-Liberston Family Foundation. The gift has led to the creation of a permanent fund at Unity Health Foundation dedicated to Behavioral Health Services at Unity Health System.

I am happy to report that this year's gala, held on April 25th and themed "An Evening to Remember on the Orient Express," raised \$95,000, making it the second largest net profit in the event's history.

I would like to take this opportunity to thank the many volunteers and supporters of the 30th Annual Ralph P. DeStephano Memorial Golf Classic. In celebration of the tournament's 30 successful years, three courses were enjoyed by 380 golfers, raising a record \$155,000. Thank you to everyone who participated!

We are mindful that all of these achievements are only possible through your generosity. We extend our gratitude for your support and friendship as we work together to serve the needs of those for whom Unity cares.

Mr. August was a former Unity Health System trustee as well as a significant benefactor. Along with his wife, Jean, and members of his family, including his brother, Burt August Sr., Mr. August was a major contributor to the August Family Birth Place at Unity Hospital in the late 1990s. Most recently, he and his wife, Jean, along with their son Andrew, a current Unity Health System trustee, and Charles' brother Burt, issued a challenge grant that successfully raised over \$1 million for the new Timothy R. McCormick Transitional Care Center.

Mr. August's lifetime of generosity touched tens of thousands of individuals across Rochester served by the many organizations and agencies he supported. In addition to a loving family, Charles August leaves behind a legacy of commitment to community that will serve as a shining example for others to follow for generations to come.

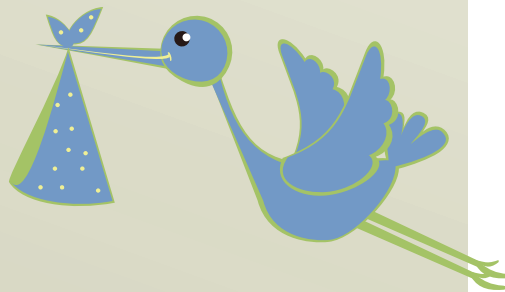
